SUMMER BASKETBALL LEAGUE PARTICIPATION APPROVAL FORM

In compliance with the NCAA regulations regarding summer basketball leagues (bylaw 14.7.4 and 14.7.4.1), I request official permission to participate in the league listed below. Further, I am aware of the following restrictions by which the NCAA certifies summer league competition:

- Dates of competition **MUST** be certified by the NCAA and can only occur between June 15 and August 31.
- No more than two players with remaining eligibility from any Division I college or junior college may participate on any one team
- The League and its member teams cannot have on its staff any person employed in any capacity at a college, university or junior college
- No team may pay a player's expenses, either directly or indirectly
- All players must limit their participation to one team in one league
- No fees, admission, etc. may be charged for a game; no revenue can be realized.
- No all-star games of any kind are permitted
- Playoffs are limited to intra-league competition and must be completed by August 31
- League play must be within 100 miles of the student athlete's official residence or within 100 miles of the student's institution
- The league may not be conducted at a venue where sports' wagering is permitted.
- No agents may be involved in any capacity with the league
- Awards may be given but only if the cost of awards is included in the participation/entry fee
- There must be proof of medical insurance coverage for league participants.
